AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE TO ENTER INTO A CONTRACT OR CONTRACTS, ACCORDING TO LAW, FOR THE PURCHASE OF ANNUAL REQUIREMENTS OF CERTAIN MATERIALS AND SUPPLIES FOR USE BY THE WATER AND SEWER DIVISION DURING 2012, AND DECLARING AN EMERGENCY.

BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County of Summit and State of Ohio, that:

<u>Section 1</u>. The Director of Public Service is hereby authorized to enter into a contract or contracts, according to law, for the purchase of the following materials and supplies for use by the Water and Sewer Division during 2012:

 Miscellaneous Plant Repairs and Repair Parts
Well Maintenance and Repairs
Miscellaneous Waterline Supplies
Fire hydrants and related Materials
Purification Chemicals
Utility Patch Program
Zeolite ion-exchange media
Meters and Related Materials

<u>Section 2</u>. The Director of Finance is hereby authorized and directed to make payment for same from the Water Fund and Sewer Fund, line item Other Operations.

<u>Section 3</u>. Any other ordinances and resolutions or portions of ordinances and resolutions inconsistent herewith are hereby repealed, but any ordinances and resolutions or portions of ordinances and resolutions not inconsistent herewith and which have not previously been repealed are hereby ratified and confirmed.

 Section 4. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Chapter 107 of the Codified Ordinances.

Section 5. This ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, convenience and welfare of the City of Cuyahoga Falls and the inhabitants thereof and
