Ms. Nichols-Rhodes stated that tonight's meeting will begin with Mayor Walters giving a presentation to the Falls Cancer Club. Mayor Walters thanked Council for allowing him to present this at the Council meeting. This is the 70th anniversary of Falls Cancer Club. For that long, they have been helping local cancer survivors in the city with numerous fundraisers that they have each year. They help with medication, doctor bills and even some medical equipment for those that need it. This Friday, at 7 p.m., is a very large fundraiser they have, the Police versus Fire basketball game, at the Cuyahoga Falls High School gymnasium. The dollars stay locally. Unfortunately, there's always going to be a need. Mayor Walters stated that this group does amazing things. Mayor Walters presented Ms. Cozy Richard, President of the Falls Cancer Club, with an Honorary Boulevard sign for their organization to proudly hang wherever they see fit.

Ms. Richard thanked Mayor Walters. She stated that the Falls Cancer Club has their meetings at a church on Chestnut Boulevard once a month. Anyone that would like to be a member is welcome to join. It is an all-volunteer organization. They have over 78 patients right now. They pay the co-payment for each one of those patients for their doctors, hospitals and CAT scans. They have an account set up at Klein's Pharmacy that gives them \$400 worth of free prescription drugs that they will not have to pay for. If they bring a prescription into Klein's, and they're a patient of the club, the club pays \$400 and they pay whatever the balance is after that. Each patient is assigned a visitor who contacts their patient once a month to see if they need any help, any kind of facility, someone to talk to, or whatever else they can do for them. It is a very rewarding club. Ms. Nichols-Rhodes asked all the members of the Falls Cancer Club who were present to stand, so they could be recognized.

Ms. Nichols-Rhodes stated that she, along with some of the other Council members, was present at the Community Forum Related to Student Safety on Thursday night. She wanted to say that Cuyahoga Falls is a lucky community to have the people they do working on behalf of all the residents. They addressed a multitude of tough questions and ideas from the public in reaction to the school shooting that recently occurred. People are concerned. The safety forces work with the schools and with City Hall. For years, people have worked together to make sure that kids are safe. She was amazed by all the information that she learned. Police officers are in the schools all the time. In addition to the school resource officer, who spends their time at the school every day, 21 schools received more than 220 visits last year of officers visiting the schools. They work on the communication with the schools and the officers and the teachers. Ms. Nichols-Rhodes stated that she wanted to thank Mayor Walters and the other representatives that were at the meeting, Chief Davis, Chief Moledor, Officer Dennis, Perry Tabak, Silver Lake Mayor Hovey and Police Chief Conley. It was a wonderful presentation. She stated she wants to assure everyone that couldn't be there that they are in good hands.
