Miscellaneous Business

Mr. Brillhart opened the floor for City Council members to give a shout-out to anyone or anything happening in their respective wards.

Mr. Stams stated that he would like to recognize long-time Northampton Historical Society President David Brown. Last week, a decision was made to preserve the Keyser-Swain Farmhouse located in Ward 8 off of West Bath Road. He also wanted to thank Ms. Sara Kline, Parks and Recreation Superintendent, along with Mr. Mike Fallis and Mr. Matt Dickinson for arranging the first meeting with Mr. Brown.

Mr. Balthis stated a resident on Bailey Road brought to his attention that they saw a sanitation truck going down to road and, when trash fell out, the driver took the time to stop the vehicle and pick up the trash.

Mr. Iula announced that early voting starts next Tuesday at 8:00 a.m. Anybody can go in and get an absentee ballot or go to the Board of Elections and vote early. The last day to register to vote is Monday, October 4.

Mrs. Penta reminded everyone that the Fire Truck Pull on October 16th at 11:00 a.m. is a worthy cause. It benefits The Pantry on The Corner in Ward 3.

Mrs. Spinner stated that she had the privilege of attending of National Park Land Day at High Bridge Glens Park, along with Councilwoman Nichols-Rhodes, on Saturday. They were delighted to have a very thorough presentation by Akron Honey on the importance of native plants and pollination.

Ms. Nichols-Rhodes stated that there was a ribbon cutting for an organization called Closet of Caring. It was started by a woman in the community who collects items to give to houseless people. This week, they are collecting things for the Battered Women's Shelter. At that ribbon cutting, they heard from Nathan from Hope Soap who does a lot of outreach and helps a lot of people. Cuyahoga Falls is a hotbed of growth for good.

Mr. Miller stated that he would like to highlight that audio for all the Council meetings can be found online. It is a great service a lot of people do not know is available. He was personally able to take advantage of that service and listen to the meeting he was unable to attend last week.

Mr. Brillhart stated that he appreciates the City's Engineering Department. That new trail is coming along. There was great supervision there and they got it moving. The Administration did a wonderful job controlling the weather for the Octoberfest. It was well attended and well done. The Farmer's Market is outstanding and High Bridge Park is an excellent location for it.

Mr. Bryan Hoffman, Finance Director, presented Report 21. The General Fund revenue side of this report is positive. Under Property Tax, they are seeing reappraisal growth. The final settlement has not been collected, but they expect about 12-percent growth in property tax revenues this year. The one area that they do not have a good gauge on yet is the Blossom Music Center Admissions Tax. They did not budget for a full schedule this year because, with COVID, they did not know exactly what was going to happen with the shows.

The expense side of the General Fund is pretty flat this year. What they do not have in there are any increases to wages. They are in negotiations this year, so those were not included in the budget

numbers. In the Municipal Income Tax line item, they saw steady growth this year. Wages have increased throughout the city and throughout the country in the private sector, fueling growth resulting in positive withholding taxes throughout the year. In the Street Construction Maintenance Repair Fund, they have seen a steady growth of the gasoline tax of about five percent from last year. They have seen a slight increase to the hotel-motel tax. They have reached their budget number for this year.

Looking forward into the Leisure Time Fund and Natatorium and the other facilities throughout the city, they expect growth in the Natatorium numbers. They are hopeful that the Natatorium memberships will start to grow in the fall. They have seen good numbers in all of the other outdoor facilities: Waterworks, Brookledge and Downview. The Natatorium does an excellent job of keeping expenses in line with those revenues so they do not fall out of line. All facilities are doing an impressive job in keeping the fund balance in the positive. On the Self-Insurance side, claims have been flat for the last year. The plan is running fairly well. They have kept premiums at last year's levels, so there is no concern for running out of money.

Mr. Stams asked how growth at the golf course has been the last few years. Mr. Hoffman stated that growth at the golf course has been a bright spot in the city. Last year, they did not see it, because there were a couple of months where they did not have any revenue because of COVID, but, this year, they have rebounded very nicely and, historically, have been on the positive side.

Mr. James moved to adjourn, second by Mr. Iula. Motion passed, voice vote (11-0). Meeting adjourned at 7:12 p.m.
