ORDINANCE NO. 16 - 2023

AN ORDINANCE AUTHORIZING THE PARKS AND RECREATION BOARD TO ENTER INTO A CONTRACT, WITHOUT COMPETITIVE BIDDING, WITH TRACKMAN, INC. FOR THE PURCHASE OF A GOLF SIMULATOR, AND DECLARING AN EMERGENCY.

WHEREAS, Brookledge Golf Club seeks to improve its golf training facilities with an indoor golf simulator; and

WHEREAS, TrackMan, Inc. is the sole source provider of leading simulator technology; and

WHEREAS, the addition of an indoor golf simulator will allow for year-round training and instruction at Brookledge Golf Club.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County of Summit and State of Ohio, that:

Section 1. The Parks and Recreation Board is hereby authorized to enter into a contract, without competitive bidding, with TrackMan, Inc. for the purchase of an indoor golf simulator at Brookledge Golf Club.

Section 2. The Director of Finance is hereby authorized to make payment for same from the Recreation Levy Fund, line item Capital Outlay.

Section 3. Any other ordinances and resolutions or portions of ordinances and resolutions inconsistent herewith are hereby repealed, but any ordinances and resolutions or portions of ordinances and resolutions not inconsistent herewith and which have not previously been repealed are hereby ratified and confirmed.

Section 4. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including, to the extent applicable, Chapter 107 of the Codified Ordinances.

Section 5. This ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, convenience and welfare of the City of Cuyahoga Falls and the inhabitants thereof and provided it receives the affirmative vote of two-thirds of the members elected or


51 appointed to Council, it shall take effect and be in force immediately upon its
