8 AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC
9 SERVICE TO ENTER INTO A CONTRACT OR CONTRACTS,
10 WITHOUT COMPETITIVE BIDDING, FOR THE STABILIZATION OF
11 AKRON-PENINSULA ROAD IN THE CITY OF CUYAHOGA FALLS,
12 AND DECLARING AN EMERGENCY.

14 WHEREAS, Akron-Peninsula Road is in emergency need of repair and stabilization, eliminating
15 the need for competitive bidding; and

16
17 WHEREAS, the Water Department has identified a contractor, River Reach Construction, which
18 provides proprietary landslide stabilization services.

19
20 NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County of
21 Summit and State of Ohio:

22
23 Section 1. That the Director of Public Service is hereby authorized to enter into a contract or
24 contracts, without competitive bidding, for the stabilization of Akron-Peninsula Road, in the City of
25 Cuyahoga Falls.



27 Section 2. That the Director of Finance is hereby authorized and directed to make payment
28 for same from the Storm Drainage Utility Fund, line item Capital Outlay.

30 Section 3. That any other ordinances or resolutions or portions of ordinances and resolutions
31 inconsistent herewith be and the same are hereby repealed, but any ordinances and resolutions
32 not inconsistent herewith and which have not previously been repealed are hereby ratified and
33 confirmed.



35 Section 4. That it is found and determined that all formal actions of this Council concerning
36 and relating to the adoption of this ordinance were adopted in an open meeting of this Council, and
37 that all deliberations of this Council and of any of its committees that resulted in such formal
38 action, were in meetings open to the public, in compliance with all legal requirements including
39 Chapter 107 of the Codified Ordinances.

41 Section 5. That this ordinance is hereby declared to be an emergency measure necessary for
42 the preservation of the public peace, health, safety, convenience and welfare of the City of Cuyahoga
43 Falls and the inhabitants thereof, and provided it receives the affirmative vote of two thirds of the
44 members elected or appointed to Council, it shall take effect and be in force immediately upon its
45 passage and approval by the Mayor; otherwise it shall take effect and be in force at the earliest
46 period allowed by law.
