7 AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC
8 SERVICE TO ENTER INTO A MODIFICATION OF CONTRACT
9 NO. 8100 WITH QUALITY CONTROL INSPECTION, INC., AND
10 DECLARING AN EMERGENCY.

12 WHEREAS, pursuant to the authority of Board of Control on or about September 21, 2020,
13 the Director of Public Service entered into Contract No. 8100, with Quality Control Inspection,
14 Inc., to provide materials testing and contract administration services for the West Steels
15 Corners Road Resurfacing (the "Project"); and

16
17 WHEREAS, for the Project to proceed, the City desires to continue materials testing and
18 contract administration services which will benefit the Project.

19
20 NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls,
21 County of Summit and State of Ohio, that:

22
23 Section 1. The Director of Public Service is hereby authorized to enter into a modification
24 of Contract No. 8100, with Quality Control Inspection, Inc., in an amount not to exceed
25 \$18,732.00. The total contract price after modification as authorized herein shall not exceed
26 \$64,213.00.



28 Section 2. The Director of Finance is hereby authorized and directed to make payment
29 for same from the Capital Projects Fund, line item Capital Outlay.

31 Section 3. Any other ordinances and resolutions or portions of ordinances and
32 resolutions inconsistent herewith are hereby repealed, but any ordinances and resolutions or
33 portions of ordinances and resolutions not inconsistent herewith and which have not
34 previously been repealed are hereby ratified and confirmed.

36 Section 4. It is found and determined that all formal actions of this Council concerning
37 and relating to the adoption of this ordinance were adopted in an open meeting of this Council,
38 and that all deliberations of this Council and of any of its committees that resulted in such
39 formal action, were in meetings open to the public, in compliance with all legal requirements,
40 to the extent applicable, including Chapter 107 of the Codified Ordinances.

41
42 Section 5. This ordinance is hereby declared to be an emergency measure necessary for
43 the preservation of the public peace, health, safety, convenience and welfare of the City of
44 Cuyahoga Falls and the inhabitants thereof, and provided it receives the affirmative vote of
45 two thirds of the members elected or appointed to Council, it shall take effect and be in force
46 immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be
47 in force at the earliest period allowed by law.
