5 ORDINANCE NO. 27 - 2021

7 AN ORDINANCE AUTHORIZING THE DIRECTOR OF  
8 PUBLIC SERVICE TO ENTER INTO A MODIFICATION  
9 OF CONTRACT NO. 8076 WITH LAKE ERIE  
10 CONSTRUCTION COMPANY AND DECLARING AN  
11 EMERGENCY.  
12

13 WHEREAS, pursuant to the authority of Board of Control on or about August  
14 10, 2020, the Director of Public Service entered into Contract No. 8076, with Lake  
15 Erie Construction Company to provide emergency overhead sign repairs on State  
16 Route 8, (the "Project"); and  
17

18 WHEREAS, Ohio Revised Code §735.051 authorizes this Council to waive  
19 formal competitive bidding and advertising for contracts where there is a real and  
20 present emergency arising in connection with the operation and maintenance of  
21 a municipally-owned facility; and  
22

23 WHEREAS, the Ohio Department of Transportation has agreed to reimburse  
24 the City at a rate of fifty percent (50%) of the eligible items of expense.  
25

26 NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga  
27 Falls, County of Summit and State of Ohio, that:  
28

29 Section 1. The Director of Public Service is hereby authorized to enter into a  
30 modification of Contract No. 8076, with Lake Erie Construction Company in an  
31 amount not to exceed \$20,400.00. The total contract price after modification as  
32 authorized herein shall not exceed \$70,400.00.  
33

34 Section 2. The Director of Finance is hereby authorized and directed to make  
35 payment for same from the Capital Projects Fund, line item Capital Outlay.  
36

37 Section 3. Any other ordinances and resolutions or portions of ordinances and  
38 resolutions inconsistent herewith are hereby repealed, but any ordinances and  
39 resolutions or portions of ordinances and resolutions not inconsistent herewith  
40 and which have not previously been repealed are hereby ratified and confirmed.  
41

42 Section 4. It is found and determined that all formal actions of this Council  
43 concerning and relating to the adoption of this ordinance were adopted in an  
44 open meeting of this Council, and that all deliberations of this Council and of any  
45 of its committees that resulted in such formal action, were in meetings open to  
46 the public, in compliance with all legal requirements, to the extent applicable,  
47 including Chapter 107 of the Codified Ordinances.  
48

49 Section 5. This ordinance is hereby declared to be an emergency measure  
50 necessary for the preservation of the public peace, health, safety, convenience  
51 and welfare of the City of Cuyahoga Falls and the inhabitants thereof, and  
52 provided it receives the affirmative vote of two thirds of the members elected or

53 appointed to Council, it shall take effect and be in force immediately upon its  
54 passage and approval by the Mayor; otherwise it shall take effect and be in force  
55 at the earliest period allowed by law.


