7 AN ORDINANCE APPROVING AND AUTHORIZING THE MAYOR TO
8 EXECUTE A COMMUNITY DEVELOPMENT BLOCK GRANT
9 AGREEMENT WITH R2K CONTRACTING, INC., IN AN AMOUNT
10 NOT TO EXCEED \$67,921.00 AND DECLARING AN EMERGENCY

12 WHEREAS, the City receives Community Development Block Grant (CDBG)
13 funds from the Department of Housing and Urban Development; and

14
15 WHEREAS, CDBG funds can be used to assist with Americans with Disabilities
16 Act (ADA) compliant renovations and modifications of public facilities; and

17
18 WHEREAS, renovations and modifications of the first floor restrooms at the Quirk
19 Cultural Center, located at 1201 Grant Avenue, Cuyahoga Falls, Ohio 44223, are
20 necessary to meet ADA compliance standards; and

22 WHEREAS, the City of Cuyahoga Falls wishes to enter into a CDBG Agreement
23 with R2K Contracting, Inc., in an amount not to exceed \$67,921.00 for ADA-compliant
24 renovations and modifications to the first-floor restrooms at Quirk Cultural Center,
25 located at 1201 Grant Avenue, Cuyahoga Falls, Ohio 44223.

27 NOW THEREFORE, BE IT ORDAINED, by the Council of the City of Cuyahoga
28 Falls, County of Summit, and State of Ohio that:

30 Section 1. The Mayor is authorized to enter into a Community Development Block
31 Grant (CDBG) agreement with R2K Contracting, Inc., in an amount not to exceed
32 \$67,921.00 for Americans with Disabilities Act compliant renovations and modifications
33 to the first-floor restrooms at Quirk Cultural Center, located at 1201 Grant Avenue,
34 Cuyahoga Falls, Ohio 44223.



36 Section 2. The Director of Finance is authorized to increase appropriations in
37 CDBG, fund line item Capital Outlay by \$67,921 and decrease appropriations in CDBG
38 Fund, line item Other Operations by \$67,921 and make payment for the same from
39 CDBG Fund, line item Capital Outlay.

41 Section 3. It is found and determined that all formal actions of this Council and
42 concerning and relating to the adoption of this ordinance were adopted in an open
43 meeting of this Council, and that all deliberations of this Council and of its committees
44 that resulted in such formal action, were in meetings open to the public, in compliance
45 with all legal requirements, to the extent applicable, including Chapter 107 of the
46 Codified Ordinances.

47
48 Section 4. This ordinance is hereby declared to be an emergency measure necessary
49 for the preservation of the public peace, health, safety, convenience and welfare of the
50 City of Cuyahoga Falls and the inhabitants thereof, and provided that it receives the


51 affirmative vote of two-thirds of the members elected or appointed to Council, it shall
52 take effect and be in force immediately upon its passage and approval by the Mayor;
53 otherwise it shall take effect and be in force at the earliest period allowed by law.
