7 AN ORDINANCE AUTHORIZING THE MAYOR OR HIS
8 DESIGNEE TO ENTER INTO A CONTRACT OR
9 CONTRACTS, WITHOUT COMPETITIVE BIDDING,
10 WITH ATLANTIC EMERGENCY SOLUTIONS, INC.
11 FOR VARIOUS VEHICLE REPAIRS, SUPPLIES AND
12 EQUIPMENT USED BY THE FIRE DEPARTMENT,
13 AND DECLARING AN EMERGENCY.

15 WHEREAS, Atlantic Emergency Solutions, Inc. has specialized knowledge and
16 expertise in servicing Fire Department vehicles; and

17
18 WHEREAS, the City has contracted with Atlantic Emergency Solutions, Inc.
19 for repair services to various Fire Department vehicles throughout the year; and

20
21 WHEREAS, although no specific expenditure for these vehicle repairs has
22 individually exceeded the threshold competitive bidding amount to date,
23 collectively these expenditures may soon exceed the competitive bidding amount
24 of \$50,000; and

25
26 WHEREAS, due to the high quality of repairs and competitive pricing for
27 equipment and supplies, the City desires to continue using Atlantic Emergency
28 Solutions, Inc. to service various Fire Department vehicles throughout the year
29 and to provide necessary equipment and supplies.

30
31 NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga
32 Falls, County of Summit and State of Ohio, that:

33
34 Section 1. The Mayor is hereby authorized to enter into a contract or
35 contracts, without competitive bidding, with Atlantic Emergency Solutions, Inc.
36 for various vehicle repairs, equipment and supplies used by the Fire Department
37 in a total amount not to exceed \$70,000 for the 2021 fiscal year.

39 Section 2. The Director of Finance is hereby authorized and directed to make
40 payment for same from the General Fund, Fire Department, line item Other
41 Operations.

43 Section 3. Any ordinances or resolutions or portions of ordinances and
44 resolutions inconsistent herewith be and the same are hereby repealed, but any
45 ordinances and resolutions not inconsistent herewith and which have not
46 previously been repealed are hereby ratified and confirmed.

47
48 Section 4. It is found and determined that all formal actions of this Council
49 concerning and relating to the passage of this ordinance were taken in an open
50 meeting of this Council and that all deliberations of this Council and of any

51 committees that resulted in those formal actions were in meetings open to the
52 public, in compliance with all legal requirements including Chapter 107 of the
53 Codified Ordinances.

54

55 Section 5. This ordinance is hereby declared to be an emergency measure
56 necessary for the preservation of the public peace, health, safety, convenience
57 and welfare of the City of Cuyahoga Falls and the inhabitants thereof, and
58 provided it receives the affirmative vote of two-thirds of the members elected or
59 appointed to Council, it shall take effect and be in force immediately upon its
60 passage and approval by the Mayor; otherwise it shall take effect and be in force
61 at the earliest period allowed by law.


