7 AN ORDINANCE AMENDING ORDINANCE 125-2021
8 AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE TO
9 ENTER INTO A CONTRACT OR CONTRACTS, ACCORDING
10 TO LAW, FOR THE PURCHASE OF ANNUAL
11 REQUIREMENTS OF CERTAIN MATERIALS, SUPPLIES AND
12 SERVICES FOR USE BY THE WATER DIVISION DURING
13 2022, MAKING THE NECESSARY APPROPRIATIONS FOR
14 THE SAME, AND DECLARING AN EMERGENCY.

15
16 WHEREAS, the Water and Sewer Divisions have endured unforeseeable cost
17 increases during 2022, necessitating an increase in their annual requirements.

18
19 NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls,
20 County of Summit and State of Ohio, that:

22 Section 1. The Director of Public Service is hereby authorized to enter into a contract
23 or contracts, according to law, for the purchase of the City’s requirements for the
24 following services, materials and supplies for use by the Water and Sewer Division
25 during 2022:

- 26 Water Treatment Chemicals
- 27 Utility Patch Program
- 28 Meters and Related Materials
- 29 Miscellaneous Equipment, Repairs, and Repair Parts
- 30 Waterline and Sewer Line Supplies
- 31 Fire Hydrants and Related Materials

34 Section 2. The authorized aggregate expenditure limit authorized by Ordinance 125-
35 2021 is increased by \$275,000.00 from \$821,620.00 to \$1,096,620.00.

37 Section 3. Furthermore, the Director of Finance is authorized to increase
38 appropriations in the Water Fund, line Item Other Operations and decrease
39 appropriations in the Water Fund, line item Capital Outlay by \$275,000.00.

41 Section 4. Notwithstanding as an exception to Section 181.06 of the Codified
42 Ordinances, Water Division expenditures made under the contracts authorized by this
43 ordinance shall not exceed, in the aggregate, \$1,096,620.00.

45 Section 5. The Director of Finance is hereby authorized and directed to make
46 payment for same from the Water and Sewer Fund, line item Other Operations.

47
48 Section 6. Any other ordinances and resolutions or portions of ordinances and
49 resolutions inconsistent herewith are hereby repealed, but any ordinances and

50 resolutions or portions of ordinances and resolutions not inconsistent herewith and
51 which have not previously been repealed are hereby ratified and confirmed.

53 Section 7. It is found and determined that all formal actions of this Council
54 concerning and relating to the adoption of this ordinance were adopted in an open
55 meeting of this Council and that all deliberations of this Council and of any of its
56 committees that resulted in such formal action were in meetings open to the public, in
57 compliance with all legal requirements including Chapter 107 of the Codified
58 Ordinances.

60 Section 8. This ordinance is hereby declared to be an emergency measure necessary
61 for the preservation of the public peace, health, safety, convenience and welfare of the
62 City of Cuyahoga Falls and the inhabitants thereof and provided it receives the
63 affirmative vote of two-thirds of the members elected or appointed to Council, it shall
64 take effect and be in force immediately upon its passage and approval by the Mayor;
65 otherwise, it shall take effect and be in force at the earliest period allowed by law.
