7 ORDINANCE NO. 67 - 2022

9 AN ORDINANCE AUTHORIZING THE PARK AND  
10 RECREATION BOARD TO ENTER INTO A CONTRACT OR  
11 CONTRACTS, ACCORDING TO LAW, FOR THE  
12 RENOVATION OF BROOKLEDGE GOLF CLUB  
13 CLUBHOUSE, AND DECLARING AN EMERGENCY.

15 WHEREAS, Brookledge Golf Club Clubhouse was built in 1990; and

16  
17 WHEREAS, the City desires to implement an architectural design considering interior and exterior  
18 components that is appropriate for the community, modernizes the look and feel and improves functionality  
19 of the existing structure; and

20  
21 WHEREAS, the City plans to incorporate several known capital maintenance projects within the overall  
22 renovation.

23  
24 NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County of Summit,  
25 and State of Ohio, that:

26  
27 Section 1. The Park and Recreation Board is hereby authorized to enter into a contract or contracts,  
28 according to law, for the renovation of Brookledge Golf Club Clubhouse.



30 Section 2. The Director of Finance is hereby authorized and directed to make payment for same from  
31 the Recreation Levy Fund, line item, Capital Outlay.



33 Section 3. Any ordinances or resolutions or portions of ordinances and resolutions inconsistent  
34 herewith are hereby repealed, but any ordinances and resolutions not inconsistent herewith and which  
35 have not previously been repealed are hereby ratified and confirmed.

37 Section 4. It is found and determined that all formal actions of this Council concerning and relating  
38 to the passage of this ordinance were taken in an open meeting of this Council and that all deliberations of  
39 this Council and of any committees that resulted in those formal actions were in meetings open to the  
40 public, in compliance with all legal requirements including Chapter 107 of the Codified Ordinances.

42 Section 5. This ordinance is hereby declared to be an emergency measure necessary for the  
43 preservation of the public peace, health, safety, convenience and welfare of the City of Cuyahoga Falls and  
44 the inhabitants thereof and provided it receives the affirmative vote of two-thirds of the members elected or  
45 appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the  
46 Mayor; otherwise, it shall take effect and be in force at the earliest period allowed by law.
