CITY OF CUYAHOGA FALLS, OHIO ORDINANCE NO. 69 - 2022

AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE TO ENTER INTO A MODIFICATION OF CONTRACT NO. 8533 WITH THE THRASHER GROUP, INC., AND DECLARING AN

EMERGENCY.

WHEREAS, the City followed the procedures set forth in Ohio Revised Code Sections 153.65 to 153.73 in selecting a professional design services firm for the design of roadway improvements at State Road/Wyoga Lake Road/Seasons Road; and

WHEREAS, after review of all the proposals submitted to the City, The Thrasher Group, Inc. (Thrasher) was selected as the most qualified for the project; and

WHEREAS, pursuant to the authority of the Board of Control on or about May 2, 2022, the Director of Public Service entered into Contract No. 8533, with Thrasher to provide Professional Engineering services for the design of roadway improvements at State Road/Wyoga Lake Road/Seasons Road (the "Project"); and

WHEREAS, for the Project to proceed, the City desires to continue Professional Engineering services which will benefit the Project.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County of Summit and State of Ohio, that:

- <u>Section 1.</u> The Director of Public Service is hereby authorized to enter into a modification of Contract No. 8533, with Thrasher in an amount not to exceed \$300,000.00. The total contract price after modification as authorized herein shall not exceed \$350,000.00.
- <u>Section 2.</u> The Director of Finance is hereby authorized and directed to make payment for same from the Capital Projects Fund, line item Capital Outlay.
- Section 3. Any other ordinances and resolutions or portions of ordinances and resolutions inconsistent herewith are hereby repealed, but any ordinances and resolutions or portions of ordinances and resolutions not inconsistent herewith and which have not previously been repealed are hereby ratified and confirmed.
- <u>Section 4.</u> It is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, to the extent applicable, including Chapter 107 of the Codified Ordinances.
- <u>Section 5.</u> This ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, convenience and welfare of the City of Cuyahoga Falls and the inhabitants thereof and provided it receives the affirmative vote of two thirds of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force at the earliest period allowed by law.
