7 AN ORDINANCE APPROVING AND AUTHORIZING THE MAYOR TO EXECUTE
8 AND SUBMIT THE ANNUAL ACTION PLAN TO THE U.S. DEPARTMENT OF
9 HOUSING AND URBAN DEVELOPMENT FOR PROGRAM YEAR 2022, AND
10 DECLARING AN EMERGENCY.

12 WHEREAS, as a prerequisite to receive the 2022 Program Year Community Development Block Grant
13 ("CDBG") allocation, the City is required to submit an Annual Action Plan to the Department of Housing and
14 Urban Development ("HUD"), that outlines the ways in which it plans to utilize its CDBG allocation for Program
15 Year 2022; and

17 WHEREAS, the City anticipates receiving an approximate allocation of \$645,000 in CDBG funding for
18 Program Year 2022; and

20 WHEREAS, the Department of Community Development has prepared the Annual Action Plan for Program
21 Year 2022 as required by HUD.

23 NOW THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County of Summit, and
24 State of Ohio, that:

26 Section 1. The Mayor is hereby authorized to execute and submit the Annual Action Plan for Program Year
27 2022 to the U.S. Department of Housing and Urban Development for the Community Development Block Grant
28 Program and the Community Development Department is authorized to carry out the programs contained within
29 this document.

31 Section 2. The Mayor, Director of Finance, Director of Community Development, Director of Law, and any
32 other public officials, individually or collectively as may be appropriate, are authorized to prepare and execute
33 such other documents, including contracts, and do all other things as necessary or incidental to carrying out the
34 intent and requirements of the Community Development Block Grant Program and/or this ordinance.

36 Section 3. Any other ordinances or resolutions or portions of ordinances and resolutions inconsistent
37 herewith are hereby repealed, but any ordinances and resolutions not inconsistent herewith and which have not
38 previously been repealed are hereby ratified and confirmed.



40 Section 4. It is found and determined that all formal actions of this Council concerning and relating to the
41 adoption of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this
42 Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in
43 compliance with all legal requirements, to the extent applicable, including Chapter 107 of the Codified Ordinances.

45 Section 5. This ordinance is hereby declared to be an emergency measure necessary for the preservation of
46 the public peace, health, safety, convenience and welfare of the City of Cuyahoga Falls and the inhabitants thereof,
47 and provided that it receives the affirmative vote of two-thirds of the members elected or appointed to Council, it
48 shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take
49 effect and be in force at the earliest period allowed by law.
