8 AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER
9 INTO A CONTRACT OR CONTRACTS, WITHOUT
10 COMPETITIVE BIDDING, WITH GVS GETAC VIDEO FOR THE
11 PURCHASE OR LEASE OF BODY AND CRUISER VIDEO
12 CAMERAS AND ALL NECESSARY ACCESSORIES FOR USE
13 BY THE POLICE DEPARTMENT, AND DECLARING AN
14 EMERGENCY.

16 WHEREAS, the Police Department proposes to purchase or lease cruiser and
17 body cameras, and;

18
19 WHEREAS, the cameras will enhance police services, protect police officers and
20 collect valuable video in significant events.

21
22 NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga
23 Falls, County of Summit and State of Ohio, that:

24
25 Section 1. The Mayor is hereby authorized to enter into a contract or contracts,
26 without competitive bidding, with GVS Getac Inc., for the purchase or lease of body and
27 cruiser video cameras and all necessary accessories, software, and services.

28
29 Section 2. The Director of Finance is hereby authorized and directed to make
30 payment for same from the Capital Projects Fund, line item Capital Outlay.

31
32 Section 3. Any other ordinances and resolutions or portions of ordinances and
33 resolutions inconsistent herewith are hereby repealed, but any ordinances and
34 resolutions or portions of ordinances and resolutions not inconsistent herewith and
35 which have not previously been repealed are hereby ratified and confirmed.

37 Section 4. It is found and determined that all formal actions of this Council
38 concerning and relating to the adoption of this ordinance were adopted in an open
39 meeting of this Council and that all deliberations of this Council and of any of its
40 committees that resulted in such formal action were in meetings open to the public, in
41 compliance with all legal requirements including, to the extent applicable, including
42 Chapter 107 of the Codified Ordinances.

44 Section 5. That this ordinance is hereby declared to be an emergency measure
45 necessary for the preservation of the public peace, health, safety, convenience and
46 welfare of the City of Cuyahoga Falls and the inhabitants thereof, and provided it
47 receives the affirmative vote of two-thirds of the members elected or appointed to
48 Council, it shall take effect and be in force immediately upon its passage and approval
49 by the Mayor; otherwise it shall take effect and be in force at the earliest period allowed
50 by law.
