8 A RESOLUTION SUPPORTING THE MAYOR'S SUBMISSION
9 OF AN APPLICATION TO THE COMMITTEE ON
10 TRANSPORTATION AND INFRASTRUCTURE FOR FEDERAL
11 FISCAL YEAR 2022 SURFACE TRANSPORTATION
12 PROJECTS TO COMPLETE THE GORGE TERRACE STREET
13 TRANSFORMATION PROJECT, AND DECLARING AN
14 EMERGENCY.

16 WHEREAS, the Committee on Transportation and Infrastructure is seeking funding
17 submission applications for Surface Transportation Projects, through the Committee on
18 Transportation and Infrastructure, for the Federal Fiscal Year 2022 Surface
19 Transportation Authorization legislation; and

21 WHEREAS, the City of Cuyahoga Falls has identified the need for, and proposes
22 capital improvements to public infrastructure, to wit: completing the Gorge Terrace
23 Street Transformation Project; and

25 WHEREAS, this Council expresses support for the City's application for funding
26 through the Committee on Transportation and Infrastructure, for the Federal Fiscal Year
27 2022 Surface Transportation Authorization legislation, for Surface Transportation
28 Projects located within the City of Cuyahoga Falls.

30 NOW THEREFORE, BE IT RESOLVED, by the Council of the City of Cuyahoga Falls,
31 County of Summit, State of Ohio, that:

33 Section 1. Council supports the Mayor's submission of an application to the
34 Committee on Transportation and Infrastructure for funding of Surface Transportation
35 Projects through the Federal Fiscal Year 2022 Surface Transportation Authorization
36 legislation for the purpose of completing the Gorge Terrace Street Transformation
37 Project.


39 Section 2. It is found and determined that all formal actions of this Council
40 concerning and relating to the adoption of this resolution were adopted in an open
41 meeting of this Council, and that all deliberations of this Council and of any of its
42 committees that resulted in such formal action, were in meetings open to the public, in
43 compliance with all legal requirements including Chapter 107 of the Codified
44 Ordinances.

46 Section 3. This resolution is hereby declared to be an emergency measure necessary
47 for the preservation of the public peace, health, safety, convenience and welfare of the
48 City of Cuyahoga Falls and the inhabitants thereof, and provided it receives the
49 affirmative vote of two thirds of the members elected or appointed to Council, it shall


50 take effect and be in force immediately upon its passage and approval by the Mayor;
51 otherwise it shall take effect and be in force at the earliest period allowed by law.
