7 ORDINANCE NO. 120 - 2023

9 AN ORDINANCE AUTHORIZING THE PARK  
10 AND RECREATION BOARD TO ENTER INTO A  
11 CONTRACT OR CONTRACTS FOR THE  
12 INTERIOR RENOVATION AFTER PUBLICLY  
13 ADVERTISING FOR BIDS, OF THE  
14 BROOKLEDGE GOLF CLUB CLUBHOUSE,  
15 AND DECLARING AN EMERGENCY.

18 WHEREAS, Brookledge Golf Club Clubhouse was built in 1990; and

19  
20 WHEREAS, the City desires to incorporate renovations that cater to the community's  
21 needs, by modernizing the aesthetics and functionality of the existing structure through  
22 interior improvements and enhancements to Brookledge Golf Club Clubhouse.

24 NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls,  
25 County of Summit, and State of Ohio, that:  
26

27 Section 1. The Park and Recreation Board is hereby authorized to enter into a  
28 contract or contracts, after publicly advertising for bids, for the interior renovation of  
29 Brookledge Golf Club Clubhouse.  
30

31 Section 2. The Director of Finance is hereby authorized and directed to make  
32 payment for the same from the Recreation Levy Fund, line item, Capital Outlay.  
33


34 Section 3. Any ordinances or resolutions or portions of ordinances and resolutions  
35 inconsistent herewith are hereby repealed, but any ordinances and resolutions not  
36 inconsistent herewith and which have not previously been repealed are hereby ratified  
37 and confirmed.

39 Section 4. It is found and determined that all formal actions of this Council  
40 concerning and relating to the passage of this ordinance were taken in an open meeting  
41 of this Council and that all deliberations of this Council and of any committees that  
42 resulted in those formal actions were in meetings open to the public, in compliance with  
43 all legal requirements including Chapter 107 of the Codified Ordinances.

46 Section 5. This ordinance is hereby declared to be an emergency measure necessary  
47 for the preservation of the public peace, health, safety, convenience and welfare of the  
48 City of Cuyahoga Falls and the inhabitants thereof, and provided it receives the  
49 affirmative vote of two-thirds of the members elected or appointed to Council, it shall  
50 take effect and be in force immediately upon its passage and approval by the Mayor;  
51 otherwise it shall take effect and be in force at the earliest period allowed by law.
