**Planning & Zoning:**

**Temp. Ord. A-110**

An ordinance approving a zoning map amendment for Parcels 35-00402 and 35-00517 (4344 and 4356 Wyoga Lake Road) from E-1 Employment District to MU-3 Sub-Urban Center, and declaring an emergency.

**Temp. Ord. B-1**

An ordinance authorizing and approving the Preliminary Subdivision Plat for the Ledges at Pine Ridge on Parcel 37-00221 (5008 State Road), and declaring an emergency.

**Temp. Ord. B-2**

An ordinance authorizing the Director of Public Service to enter into a contract or contracts, according to law, for the annual resurfacing and/or repair of various streets as described in Exhibit ‘A’ attached hereto, in the City of Cuyahoga Falls and authorizing the Director of Public Service to enter into a contract or contracts for pavement preservation on various streets within the City, and declaring an emergency.
